- 1) Assume all risk of possible damage or injury involved through participation in any activity planned by Douglas or FPHQ or coordinated by Douglas and FPHQ with any other person or entity.
- 2) Request permission to participate in the activity with full knowledge that said activity could result in permanent damage or injury to participant.
- 3) Agree to release, indemnify and hold harmless Douglas and FPHQ and/or its agents, officials and employees from liability resulting from my participation in said activity, including Douglas' or FPHQ's gross negligence.
